Creating the Enabling Environment for Green Economy Cooperation



Professor Jacqueline Peel, Director of Melbourne Climate Futures, The University of Melbourne (Moderator)

Professor Jacqueline Peel is a leading, internationally-recognised expert in the field of environmental and climate change law. Her scholarship on these topics encompasses international, transnational and national dimensions, as well as interdisciplinary aspects of the law/science relationship in the environmental field and risk regulation. Professor Peel was elected a Fellow of the Academy of the Social Sciences in Australia in 2019.

She is a member of the Blueprint Institute's strategic advisory council and the Grattan Institute's energy program reference panel, and was the 2020 Mission Innovation Champion for Australia.




Mr Rob Law, Director of Advisory and Insights, Asialink Business (Moderator)
